For that reason we thing that is worthwhile a reference to be made that: fees, proper fees, commission or non monetary benefits, either paid or provided to or by client or a person acting on behalf of a client or paid or provided by a third party or by a person acting on behalf of a third party, must be at the rate formed in the market under the fair competition rules, (any overestimation or underestimation must be prohibited under the provisions of article 26 of level 2 Directive).
