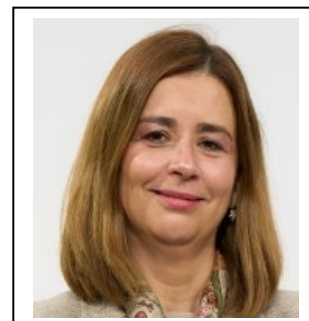


Gabriela Ariadna Dumitrescu
