The Executive Director reported on the (i) recent verification and validation of the EU Eco-Management and Audit Scheme (EMAS) certification on ESMA's environmental performance and (ii) ESMA 2024 All Staff Afternoon that took place on 24 September at ESMA's premises which focused on raising awareness around Diversity, Equity, and Inclusion topics.

The Executive Director presented the 2nd 2024 Activity Report.

The Board discussed the 2nd 2024 Activity Report, and in particular the:

- redeployment of resources as well as measures to contain costs;
- preparation for the DORA oversight responsibilities; and
- execution of IT projects; and
- update on the ongoing court case.

Conclusion: The Board discussed and took note of the 2nd 2024 Activity Report.



5. Principles on risk-based supervision in Supervisory Handbook

The Head of the Conduct Supervision and Convergence Department presented the proposed common principles on risk-based supervision to be included in the ESMA Supervisory Handbook.

The Board discussed the principles on risk-based supervision, and in particular the:

- importance of risk-based supervision as the driving principle of the EU supervisory approach;
- role of the heatmap both as input to the risk assessment at national and EU level and as output of high-quality national risk-based supervision;
- importance of the principles as a key step in the development of a common supervisory culture between ESMA and NCAs;
- need to use the principles as a basis to develop and use common tools and supervisory methodologies (leveraging for example on successful mechanisms used in the area of corporate reporting) across various areas and ESMA groups; and
- importance of introducing concrete examples and support the practical implementation of the principles over time.

Conclusion: The Board discussed and endorsed the common principles on risk-based supervision. They will be presented for approval at the next Board of Supervisors.

The Chair of the Senior Supervisors Forum presented the Report on sanctions and measures imposed in 2023.

The Board discussed the Report on sanctions and measures imposed in 2023, and in particular the:

- usefulness of having for the first time a consolidated report on all sectors;
- need for further enhancement of supervisory convergence efforts to foster effectiveness in enforcement;
- divergence in NCAs' powers stemming from national law;
- distinction between administrative and criminal sanctions, the use of which varies across Member States;
- broader picture of results of supervisory activities, as that result is not limited to sanctions; and



- possibility to further develop the next iteration of the report by including longer periods of time than 1 year for different NCAs and/or providing a wider range of data; and
- provide a deep dive analysis on one or two specific area(s) where differences are deemed most problematic from a convergence perspective.

Conclusion: The Board discussed and endorsed the Report on sanctions and measures imposed in 2023. The Board also supported publication of the Report subject to proper communication on the caveats on the limitations of the report.

- European Commission's proposal to EU agencies to provide additional support in 2024 and 2025;
- practical difficulties and constraints of the NCAs related to any additional contribution for the 2024 budget as well as the willingness of the NCAs to explore the possibility to support ESMA's budget in 2025;
- possibility to compare the cost structure across the three ESAs; and
- need to re-assess ESMA's overall funding model in the future in order to make it more sustainable.
