




























List of designated competent authorities for the purposes of Regulation (EU) No.346/2013 on European social entrepreneurship funds (EuSEF Regulation)

Article 3(m) EuSEF Regulation: " 'competent authority' means the national authority which the home Member State designates, by law or regulation, to undertake the registration of managers of collective investment undertakings falling within the scope of this Regulation. "

Article 3(a) EuSEF Regulation : " 'collective investment undertaking' means an AIF as defined in point (a) of Article 4(1) of Directive 2011/61/EU"
