For the implementation of the requirements to notify competent authorities and to publicly disclosed net short positions under Regulation (EU) No 236/2012 on short selling and certain aspects of credit default swaps, ESMA is providing the addresses of the website in the different Member States where the information on the national process for notifying and the forms to use are made available.
