Contact points of national supervisory authorities for communication in the MiFID II framework on supervisory cooperation, authorisation, acquisitions and passporting

Overview

1. This document provides information on contact points of national competent authorities (NCAs) to facilitate communication on the topics of:
 - Cooperation and exchange of information between NCAs¹
 - Consultation of other competent authorities prior to the authorisation of an investment firm²
 - Consultation process between relevant competent authorities in relation to proposed acquisition of a qualifying holding in an investment firm³
 - Passporting of investment services⁴

The information included in the Annex will be updated by ESMA to reflect any changes to the relevant detail and will be communicated to all NCAs. NCAs should inform ESMA of any changes to the details in the Annex in a timely manner.
